

## **Sedano's Supermarkets**

### **\$5,000 In Groceries**

#### **Official Rules & Regulations**

The Sedano's Supermarkets' \$5,000 in Groceries promotion consists of a registration that will begin April 10th at 12:00 a.m. ET and will end on May 31, 2019 at 11:59 p.m. ET ("Promotions Period")

**ELIGIBILITY:** Promotion is open only to legal residents of **the fifty (50) United States or the District of Columbia, 21 years of age or older** at the time of entry. Void where prohibited by law. Employees of **Sedano's ("Sponsor"), República, LLC**, and their respective parents, subsidiaries, affiliates, promotion and advertising agencies, and members of their immediate family (spouse and parent, children and siblings and their respective spouses, regardless of where they reside) and persons living in the same household, whether or not related, of such employees, are not eligible to enter or win. Promotion is subject to all applicable federal, state and local laws.

**HOW TO ENTER THE CONTEST:** During the Promotion Period, download the Sedano's Online app and complete the consumer profile. **All Sweepstakes Entries must be received by May 31, 2019 at 11:59 p.m. ET to be eligible.** Sweepstakes Entries generated by script, macro or other automated means are void. Limit of one (1) Sweepstakes Entry per person using only one (1) email address throughout the Sweepstakes Period. Sweepstakes Entries received from any person or email address in excess of the above stated limitation will be void. Except as otherwise provided herein, Sponsor will not enter into any correspondence with any entrant regarding a Sweepstakes Entry.

or

violates any applicable law.
